For the sixteenth year, a member from each Branch could win one of fourteen continuing education Scholarships or one of three Day Care Grants. The Branches are as follows: Kean, MSU, NJCU, Ramapo, Rowan (including SOM), Rutgers, Stockton, TCNJ and WPU. For the purposes of this drawing only, HESAA, CHE and TESC will serve as one Branch; Bergen County Board of Social Services, Maplewood Township Workers, Millburn Board of Education, Roselle Park Police Dispatchers, Borough of West Long Branch and UHNJ will serve as one Branch; and the 24 Libraries will serve as one Branch and be eligible for two scholarships. There will also be a combined *second chance to win* scholarship for all those not chosen the first time around from each site above.

The three Dependent Care Grants will be awarded on a statewide basis.

#### **SCHOLARSHIP ELIGIBILITY IS:**

**Applicant** must be a **CWA Local 1031 Member** or the Dependent of a **CWA Local 1031 Member**. The **applicant** must be an incoming freshman or continuing student of any vocational/technical, community, four-year college or university, or graduate professional program in the upcoming academic year.

#### **DEPENDENT CARE ELIGIBILITY IS:**

**Applicant** must be the dependent child or dependent adult of a **CWA Local 1031 Member**. The **applicant** must attend a certified program, *i.e.*, daycare, after-school care, summer camp, or adult day care, in 2018.

If there is more than one person in your family who is eligible for a Scholarship or Dependent Care Grant, you can submit one application for each person.

Winners will be notified by mail. In each case, winners *will be required to provide proof of enrollment and proof of payment*. The Executive Board reserves the right to draw

alternate applicants if the status of an applicant changes or is found to be ineligible. Drawings are not final until they are certified by the Local. **If you are currently not a CWA Local 1031 Member, now is a good time to join the union - just fill out and send in a member Authorization Card with your application to be eligible.** (See your CWA Branch President or Shop Steward to obtain an Authorization Card.)
